Universidad Central Del Caribe (UCC)



PRCCI is proud to announce its newest site member, Universidad Central Del Caribe (UCC), a Puerto Rican higher education institution specializing in health sciences.



The Universidad Central del Caribe (UCC) was founded in 1976. UCC was the first non-profit private medical school incorporated under the laws of the Commonwealth of Puerto Rico. During its history, UCC has evolved into a health-sciences university with fully accredited academic programs in Medicine, Medical Images Technology, Biomedical Sciences and Substance Abuse Counseling, and this year opened the first Chiropractic School in Puerto Rico. Its faculty has carried out an extensive agenda of biomedical, clinical, and psychosocial research and provides specialized health care services. What distinguishes UCC from other institutions in Puerto Rico is its continuing commitment to preparing high-quality health professionals who can offer preventive care, promote healthy lifestyles, and provide excellent services while maintaining a sense of humanism, compassion and the highest ethical values. Clinical research is at the heart of all medical advances, as it determines how effective and safe a treatment is and how it is best delivered. The need for clinical research is even more pressing in U.S.A. areas such as Puerto Rico given the chronic underrepresentation of minorities in

clinical trials. By joining PRCCI, the Universidad Central del Caribe will achieve synergies on access to research opportunities on some of the most important global health challenges of our time as well as on clinical research quality and speed of execution. Both organizations will contribute together to the growth of clinical research in Puerto Rico and will ultimately help improve medical care for future generations of Puerto Ricans.

"The agreement with the PRCCI allows the UCC to become a strategic partner to position Puerto Rico in clinical studies nationwide, particularly those focused on diseases in which the prevalence in Hispanics is higher. It is another milestone to fulfill one of the pillars of the mission of our University, which is the development of research in the biomedical, clinical and psychosocial sciences. The entrance to the consortium widens the networking and gives the space for our researchers and students to participate in new opportunities and provides the platform to contribute to new translational projects", said Dr. Waleska Crespo Rivera, President of the Universidad Central del Caribe. Dr. Amarilys Silva, Executive Director of PRCCI, added: "The Universidad Central del Caribe (UCC), is a great addition to our Consortium given its commitment to research providing an enriching environment that promotes the development of investigation in the biomedical, clinical and psychosocial sciences with an orientation toward the health needs of our immediate community in Puerto Rico. ### 2018 The Year of Best Practices

October has flown by in record time in 2018. PRCCI member sites have been busy on the quality front with recent sponsor and FDA audits. We are proud to recognize our member site, Emanuelli Research and Development, as they recently hosted the FDA for an audit as a top enroller with outstanding results. What's their secret? Their well developed quality management system (QMS)!

#### What is OMS?

Recently the International Council for Harmonization (ICH) released the long-anticipated ICH/GCP E6 (R2) guidance. One of the important ways clinical trial sites can focus their R2 compliance efforts is by formalizing their quality efforts into an organized quality management system (QMS). The foundation of any great QMS is meaningful standard operating procedures (SOPs). Other components include identifying key risk indicators and thresholds for action. Sites can use Human Centered Design (HCD) to ensure their QMS has a meaningful impact on quality.
